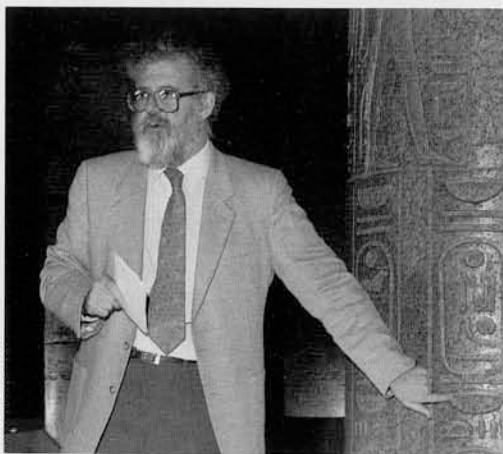


# About the Authors

**David O'Connor** is Curator-in-Charge of the Egyptian Section at The University Museum, as well as Curator of the Museum's exhibit *Ancient Nubia: Egypt's Rival in Africa*. He has played a major role in developing several exhibitions of Egyptian art and archaeology at the Museum, and has spent many field seasons in Egypt and the Sudan. He has co-authored several books, including *Ancient Egypt: A Social History* (1983), now in its seventh printing, and *Ancient Nubia: Egypt's Rival in Africa* (1994). He received his B.A. from the University of Sydney and a postgraduate diploma in Egyptology from the University of London before receiving his Ph.D. from Cambridge University.

**William Y. Adams** is Professor Emeritus of Anthropology at the University of Kentucky. In 1959 he went to the Republic of the Sudan to direct salvage excavations in the area to be flooded by the Aswan High Dam, remaining there until 1966. In that year he was appointed Professor of Anthropology at the University of Kentucky. While at Kentucky he led two additional archaeological expeditions to the Sudan and several to the site of Qasr

Ibrim in Egyptian Nubia. Adams is the author of *Nubia: Corridor to Africa*, *Ceramic Industries of Medieval Nubia*, *Archaeological Typology and Practical Reality*, and over 150 chapters and articles dealing with the archaeology and culture history of Nubia and the Sudan.



**Samia Dafa'alla** is an Assistant Professor in the Department of History at the University of Khartoum in the Sudan, specializing in Napatan and Meroitic history and culture. She was awarded a Fulbright nine-month scholarship in 1990, which she spent in Lexington affiliated with the University of Kentucky. She received a B.A. (Hons.) from the University of Khartoum, a B.A. (Hons.) from the University of Durham (U.K.) and her Ph.D. from Cambridge University (U.K.). Recent articles include "Succession in the Kingdom of Napata (Sudan) 900–300 B.C." (to appear in *The International Journal of African Historical Studies*, Vol. 26, No. 1, 1993) and "The Date of the End of the Kingdom of Napata, a Philosophical Problem" (in press, *Journal of Egyptian Archaeology*).



**Frank Snowden** is an authority on the status of Africans in the Classical and Hellenistic worlds. He received his Ph.D. from Harvard University and has had a distinguished career as teacher, scholar, administrator, and diplomat. His books include *Blacks in Antiquity: Ethiopians in the Greco-Roman Experience* (1970) and *Before Color Prejudice: The Ancient View of Blacks* (1983). Snowden is currently Professor Emeritus at Howard University.

**John Alexander** received his Ph.D. and ScD. from Cambridge University and is a Fellow at St. John's College, Cambridge. An African archaeologist, he has taught, examined, and periodically excavated in the Sudan, Egypt, and West Africa from 1948 to 1984, and is currently the Vice-Chairman of the Sudan Archaeological Research Society.
